I hereby release and discharge the City of Pittsburg, its advisory board members, volunteers, agents, servants, and employees, from all claims, demands, and causes of action of every kind for any damages, injuries, and death which may result from my participation in the Event.

I further agree to defend and hold the City of Pittsburg, its advisory board members, volunteers, agents, servants and employees harmless, and indemnify the City of Pittsburg, its advisory board members, agents, servants, and employees, from any and all claims, demands, and causes of action for damages, injuries, and death made by me or anyone on my behalf which may result from my participation in the Event.

I understand and agree that this RELEASE, WAIVER, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT shall be binding upon my heirs, executors, administrators, receivers, trustees, agents, servants, employees, and assigns.
