 - Finance has confirmed that we can sell and raise funds
 - Ben mentioned an online store to sell DAB merch, 620 Day
 - Tree made motion, Skip second budget as of 7/15, subject to change. All in favor, none opposed
- SEK-CAP Bus Signs Completed (waiting for Knights of Columbus approval)
- Bike Racks & Benches *Action Needed*
 - Received check deposit \$8,800 rather than previously stated \$10,244.80. Only short \$1,444.80 to complete the downtown bike rack/benches project.
 - Action determine next steps to order benches (4)/bike racks (3)
 - Decide on locations for these new furnishings.
 - Bike racks Root, two remaining locations open
 - Benches Library, Pritchett (sp), two remaining locations open –
 DAB come to next meeting with suggestions
 - DAB will match LiveWell's grant with the remaining funds from the DAB budget and proceed with order. Locations will be determined at next meeting.
 - Move to Approve Tree
 - Second Skip
